Wednesday August 10, 2022 Regular Meeting:

The regular meeting of the Vermillion Historic Preservation Commission was called to order at City Hall August 10, 2022 at 9:10 a.m.

1. Roll Call

2. Adoption of the Agenda

Dendinger moved to adopt the agenda, seconded by Chaney. Unanimously approved.

3. Approval of the Minutes

3a. Dendinger moved that the minutes of the July 7, 2022 meeting be adopted, seconded by Vanderhill. Unanimously approved.

5. Old Business

5a. Keith-Gray stated she talked with the leader of the gravestone workshop to find out more details and information for the group. She states they will be doing a regional tour and that Vermillion could be a possible stop and would cost no money for the HPC. If this is not pursued, it is \$3,000 a day for the workshop if hired privately for the event. Discussions will continue at the next meeting. Staff will provide point of contact for the local cemeteries.

5b. Keith-Gray would like a design of a logo made for the Prentis Park Centennial Celebration. She spoke with Carol Robertson about a possible baseball game being hosted at Prentis Park during the event. The American Legion has been talked to about possibly sponsoring this event. Wilson states that Historian David Kemp of Sioux Falls is a good contact regarding the history of baseball. Discussions will continue through the planning of the event.

6. New Business

6a. The HPC unanimously agreed that it will complete the necessary forms for both 1101 James Street and the Jolley Historic District to nominate them to the National Register of Historic Places.

- **6b.** Wilson believes we can have a public hearing regarding the work being done to 12 W. Main Street within the Downtown Historic District. He would like the property owner to present alternatives to the work being displayed in the application. Wilson would like these alternatives to be turned into the HPC before the possible public hearing. Gerrish would like to see as well what work overall will be done to the property. The group also agrees it may be best to meet with the owner first before a public hearing. Dendinger stated that even the contractor of the project would be a good person to meet with. Bird will email the owner with options of permitting only the front window replacement or to have a meeting with the HPC to show what work is needed in the entry as well.
- **6c.** Gerrish has been working on opening a brewery within the City of Vermillion at the Old Armory (115 Market Street). He would like to individually nominate the building. He

ultimately wanted to gauge the HPC's thoughts and recommendations. A formal nomination will be needed to submit for this property. Gerrish will update as he can.

- **6d.** Keith-Gray met with the Clay County HPC and discussed their procedure regarding the survey of USD buildings. Michelle Dennis of M.L. Dennis Consulting has provided guidance on the nomination process. She sent a recommendation on how the HPC should proceed. Patrick Morrison of the CCHPC will create a google doc to assist with collecting information. Gerrish will reach out to Molly Rozum of USD History to see if any students would like to assist. Keith-Gray will continue updating the group.
- **6e.** Staff will email EOI forms to all when they are out regarding Commission Member appointments.
- **6f.** The HPC discussed a possible new meeting time, electing to keep it the same as it is currently but changing it to the 2^{nd} Wednesday of every month. Next meeting is now September 14, 2022 at 9:00 a.m.
